I am happy to share that the Indian Council of Agricultural Research (ICAR) is launching a national outreach initiative titled "Viksit Krishi Sankalp Abhiyan (VKSA)", scheduled during the Pre-Kharif season from May 29 to June 12, 2025. The objective of this campaign is to bridge the gap between agricultural research and the farmer community by taking knowledge directly to the fields.
